Products

All our articles are unikat produced craft-product in affectionate, costly handicraft from recycling - or nature-materials mostly.

Since the merchandise are artistic objects and not about standardized industry-products, it is inevitable, yes even wanted that among each other it strong deviations in design, color and nature and to the photos in brochures and Internetpage gives.

We take the trouble always to grant your wishes after expressed color-wishes and Bauvarianten. Since construction and also size as well as color-variations of all illustrations can deviate, no one insists complaint-claim on it.

Lacks / return / retraction / cancellation

Obvious lacks in material or processing which prevents the application or impedes, just as transportation-damages are immediately to be reported us within 14 days after the delivery however. The general return-right for consumers within 14 days from merchandise-entrance or contract-signature it please needs a short beforehand-language since our camp is not continually busy. The ware from returns and complaints must unused and is sent back with a copy of bill or delivery note. The law stipulates that you with orders up to an amount from Euro 40,00, to carry the expenses of the return themselves, has. Otherwise, the return-expenses go to our loads. We would find it however fair if you detached all programs.

You/they have the general retraction-right of a job within 14 days on a lasting data carrier. We immediately even out payments perhaps achieved on it, it is she/it then wants to use the credit balance for another order. The retraction-right is not applied to orders, which were prepared on tidings-specification.

Since most of our articles are Special-made, we must order for finished in writing, but later than within 14 days canceled or doesn't calculate a cancellation-charge with delivery contrary to taken stations. This amounts to from 200,- € merchandise-value 20% of the net-sale-price, subject to the settlement with later performances.

MAHAFALY is not liable for damages for delivery-postponements or not-availability, if these through higher circumstances, political unrests or logistical lacks in the producer-country was caused.

Minimum-order-value / price

Please, they heed the minimum-order-value of 15,00 €S for consumers. We supply retailers from 200,00 €S for the first-order and subsequently from 50,00 € merchandise-good. We cannot process your job under it economically.

We lift on the basis of our fair-trade-concept of course, in accordance with the cost of living-index in Madagascar, the purchase-prices with our producers continuously at.

Through directly-trade and slim logistics, we try to intercept price-increases for our customers largely and to prevent.

Nevertheless all prices are regarded as subject to change, prices on old cunnings lose your validity with new cunnings. Prices for written offers are valid 4 weeks, vocal offers 2 weeks.

Mix-discounts

The acceptable of discounts at consumers takes place after agreement. For wholesale dealers, we can grant following discount-squadron: With 50 pieces of minimum-order-quantity per articles until 5,00 € and 10 pieces of minimum-order-quantity of 5,00 to 50,00 €:

- 3 % on the net-value from 3.000,00 € merchandise-good per order
- 5 % on the net-value from 5.000,00 € merchandise-good per order
- 10 % on the net-value from 10.000,00 € merchandise-good per order
- 20 % on the net-value from 15.000,00 € merchandise-good per order

A prefinancing from 20% to 50% of the order-value within 14 days after written order can be necessary.

The shipping at retailers (wholesaler price) takes place from a merchandise-value of 200,00 €S shipping-free of charge. To consumers , this is applied from 100,00 €S For each other order, we calculate a shipping-expenses-share of 6,00 €S, the attacking postage-expenses arrive from 5 kg substances. We deliver normally within a workweek with package-service if the articles are on camps.

If an article is not available within 14 days, we inform you and supply later automatically at merchandise-entrance if you don't cancel the order.

We execute orders from the foreign countries only against cash in advance on our account. Please pay after entrance of the delivery-confirmation with the proforma-bill, for us toll-free. The merchandise-shipping takes place after entrance of the sum or Fax-formular of the remittance on our account.

MAHAFALY drives no store-business. Her/it/them can buy in our pattern-camp Berlin, after date-agreement, ware and can view.

To deliveries, the German right is applied, as jurisdiction, the district court is regarded in Berlin.
